# Algeria Mourns Twelve, And Reaches For The Gallows

Algeria began three days of national mourning for twelve wildfire dead, and President Tebboune answered the fires with an order to introduce the death penalty for arson by September 15.

Kenya's main airport spent a second day on strike, Moody's cut Senegal deeper into junk over its ruling camp's power struggle, and fighting in Sudan's Blue Nile displaced nearly 20,000 people in two days.

This dossier reads the continent's severity turn: what grief is doing to policy, what the strike does to the state's asset sales, and which institutions still work quietly while the loud ones fail.

## A MOURNING, A STRIKE, A DOWNGRADE, AND A COURT FILE IN WASHINGTON

### The Severity Turn

Algeria's president looked at a map of simultaneous fires and reached for the oldest instrument a state owns. Twelve dead, 154 fires in a day, three days of mourning — and a justice minister with until September 15 to write arson into the capital statutes.

The order deserves to be read as governance, not only as anger. A president who cannot regulate the weather can regulate the response to it, and severity is the one policy lever that works on television.

The moratorium on executions has held since 1993, and the president's suspicion — that fires do not start together, at one in the morning, without wind — may even be right about some of them. Arson is real in Algeria; so is the heat.

What the statute cannot answer is the underlying arithmetic: nearly 2,000 fires were recorded nationwide in July alone, before this week's. Punishment is retrospective by nature; the climate is not.

Kenya spent the same morning demonstrating the other face of the same condition. The state's flagship airport stayed partially paralysed for a second day, while the government was still celebrating the rescue of its pipeline share sale by US\$740 million of arm-twisted state money.

A state that must coerce its own institutions to buy its assets, and cannot keep its hub airport running, is not short of ambition. It is short of ungoverned time — the gap between when a problem is named and when it is answered.

Senegal's downgrade is the market's version of the same sentence. Moody's did not hide behind the spreadsheets; it named the power struggle between the president and the prime minister's camp as the risk.

Ratings agencies are paid to be late and polite. When they become early and specific, the quarrel they describe has usually already been priced.

Blue Nile's 20,000 new displaced complete the day's map. Sudan's war no longer needs headlines to advance; it advances by village, and the villages vote with their feet.

The continent's working institutions this week are the quiet ones: a vaccination trial in Kisangani that simply began, an agency that simply said what it saw. Everything louder is a receipt for something earlier that went undone.

*Severity is what a state reaches for when prevention has already failed.*

## TWELVE FUNERALS, ONE STATUTE, AND A MORATORIUM OLDER THAN THE FIRES

### The Gallows Statute

#### Part One · What Actually Happened

Algeria's death-penalty order is best read as three documents at once: a punishment, a message and an alibi. The punishment targets arsonists; the message targets a public asking why 154 fires could burn in a day; the alibi is for a state that has not built a fire service for the climate it now lives in.

The legal mechanics are simple: arson already carries thirty years, and the president wants the maximum raised to the rope. The moratorium has held since 1993, through worse emergencies than this one, and the country's last execution predates most of its voters.

The politics are simpler: a president facing a season of fires has chosen the one response the opposition cannot outbid. Nobody in Algiers will campaign this autumn on clemency for arsonists.

The region's history offers a warning. States that answer climate stress with penal theatre — and the Sahel has several — discover that the statute outlives the emergency and is eventually used for other fires, the political kind.

The honest variable is evidence: if the arrests produce proof of coordinated arson, the statute will look like necessity to most Algerians. If they do not, it will look like what it also is — a state converting its own unpreparedness into someone else's crime.

Latin America knows this geometry intimately. Mano dura was born of the same arithmetic — a frightened public, an embarrassed state, and a punishment that photographs better than prevention ever will.

## Part Two · Three Ways This Can Go

### Possibility A · The statute passes and is used · 20%

Parliament delivers the text by the September deadline, the moratorium ends formally, and the first arson conviction under it reaches the appeal courts within a year. Algeria rejoins the small club of states that execute.

### Possibility B · The statute passes and sleeps · 55%

The law is written, the mourning ends, and the moratorium survives in practice. The statute becomes what most severity laws become: a shelf instrument, displayed at anniversaries and elections.

### Possibility C · The deadline passes quietly · 25%

September 15 arrives without a bill, the presidency stops mentioning it, and compensation cases absorb the public's attention. The order joins the long list of emergency rhetoric that emergencies outlive.

## WHO IS DECIDING THIS WEEK

### Five People Shaping The News

Five people whose decisions this week set the continent's weather.

#### **Abdelmadjid Tebboune · President of Algeria**

The author of the week's hardest sentence. His suspicion about synchronised fires may be justified; his remedy is the oldest one a state owns, and it will define his autumn either way.

#### **William Ruto · President of Kenya**

Owns both halves of the Kenyan weekend: the IPO rescue he celebrated and the airport strike he has not ended. The gap between the two is his government's honest portrait.

#### **Bassirou Diomaye Faye · President of Senegal**

The downgrade named his quarrel with his own prime minister's camp. He is one joint fiscal statement away from answering it — and has been for months.

#### **Abdel Fattah al-Burhan · Sudan's de facto leader**

Blue Nile's emptying villages are his file whether he claims them or not. A war that advances without headlines is still his war.

#### **Bola Tinubu · President of Nigeria**

His lawyers' filing in Washington did what no opponent could: put the presidency's archive on the campaign agenda. The court's calendar now outranks his communications office.

# The Day, Country By Country

The day, country by country — two sentences each, no decoration.

### ALGERIA

Three days of national mourning began for the twelve fire dead, with compensation promised regardless of the nature of the losses and alternative housing for the displaced.

The justice minister has until September 15 to deliver the arson statute; arrests have been announced, and the president's synchronised-fires suspicion is now the investigation's working theory.

### KENYA

The airport strike entered its second day, delaying thousands and sending hundreds of stranded passengers into hotels while the authority and the union traded statements.

The stoppage lands on a government still defending the pipeline IPO's rescue by US\$740 million in state money — proof, the opposition says, that the state's assets work only when coerced.

### SENEGAL

Moody's cut the rating deeper into junk and named the reason: the power struggle between the president and the prime minister's camp.

The downgrade raises the cost of the consolidation both men claim to want, which is the quarrel's whole structure.

## **SUDAN**

Nearly 20,000 people fled fighting in Blue Nile state in two days, the year's fastest displacement in the country's south-east.

The corridors toward Ethiopia's border camps are filling again; no peace track currently covers the front they flee.

## **DR CONGO**

Vaccination of frontline workers began in Kisangani under the approved trial frame, covering Tshopo, Bas-Uele and Haut-Uele.

The outbreak passed 5,600 confirmed cases on the latest regional reading; the ECDC's Thursday count stood at 5,794 confirmed and 2,786 dead.

## **NIGERIA**

President Tinubu asked a US court to keep his FBI and DEA records sealed, intervening in a freedom-of-information case.

The filing caps a week of audits: US\$28 million in presidential travel, an uncounted kidnapping in Borgu, and now an American docket.

Algeria's compensation promise, made before any assessment, sets a precedent the treasury will meet again. Fire is becoming a budget line across North Africa.

### Public health logistics

Kisangani restates the week's lesson: the response's constraint is people, not product. The trial frame makes the corridor worker the whole strategy.

### Sovereign credit

Senegal's downgrade, delivered with a political citation, marks the moment the region's ratings stopped pretending to be only about numbers.

## WHAT THE DAY ADDS UP TO

# The Honest Sentence

The continent's Monday was severity performed at several registers: a statute in Algiers, a shutdown in Nairobi, a downgrade in Dakar, a courtroom in Washington.

None of it addresses the underlying stock of undone work — fires unprevented, wages unnegotiated, budgets unsigned, records unopened. The week's real news is the gap.

The quiet exceptions deserve the last word: a vaccination that began on time, a Libyan signature withheld for five years. Prevention exists; it is simply outnumbered.

Tomorrow's test is JKIA's third day and the first detail of the Algerian arrests. Both will say more than today's statements.
